A Precious Resource

The importance of protecting our natural water sources

Although the recent rainfall was welcome, it hardly put a dent in this season's harsh drought. To date, Santa Clara County has received less than 50% of seasonal average rainfall and its reservoirs are at just 36% of capacity (*Santa Clara Valley Water District*).

Land conservation plays a major role in protecting water supplies, especially as weather patterns become more unpredictable. The Authority's *Greenprint** report offers a detailed

analysis of the County's water resources, and long-term strategies to sustain our water supplies. Strategies include

protection and restoration of upper watershed lands, which enhance the land's ability to absorb water and recharge groundwater aquifers that provide about one-half of the County's

water supply. The Authority will continue to protect the agricultural area of the Coyote Valley, a critical groundwater recharge and floodplain area for the County.

The Open Space Authority is committed to protecting our landscape's natural water sources. By doing so, we reduce the need for costly built infrastructure, help sustain local water supplies, improve water quality, and reduce flood risk.

Investing in Our Watershed Lands

The Open Space Authority protects, manages and restores open space lands to ensure that they function as healthy, intact watersheds. In fact, the Authority has strategically preserved nearly 10,000 acres of watershed lands that protect the Valley's water supply and maintain clean water by naturally filtering toxins and pollutants.

The Authority's most recent acquisition features 160+ acres off Casa Loma Road just west of Rancho Cañada del Oro Open Space Preserve. The property is lush with mixed evergreen, Coast Live Oak, and riparian forests with two seasonal tributaries to Llagas Creek, an important steelhead stream. Preservation of this property helps maintain important habitats and contributes to the protection of the Llagas Creek Watershed.



Answer: I am a watershed. Watersheds are swaths of land that absorb rainfall and snowmelt. We can cross county, state, and even international borders. Some of us are millions of square miles; others are just a few acres. We supply drinking water plus water for agriculture and manufacturing, and provide habitat to numerous plants and animals. Healthy watersheds are an important component of healthy, livable communities.

watcher, Jan infuses his hikes with stories from nature.

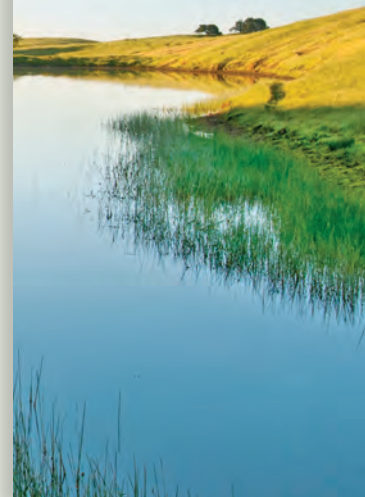
"When you get involved in nature," he says, "you find out that every plant, animal, lichen, rock—everything you see has its

Coyote Ridge Acquisition: A Local Paradise

Exquisite, pristine open space land on Coyote Ridge was protected this year with the Authority's acquisition of 28.45 acres on Malech Road in the Upper Coyote Valley Area. The property is visually stunning with its rare serpentine grassland, rock outcrops and Blue Oak Savanna. The site also contains a perennial spring and a tributary to Coyote Creek, a steelhead stream. A three-acre portion of the site offers potential for public access, environmental education and staging opportunities for a future Open Space Preserve.
